| September 2017 | Stuart James from EPA rang and left a message with Jeff | <p>Dave phoned Stuart and was told that a complaint was made by a member the public on Wednesday 13<sup>th</sup> about dust.</p> <p>Stuart told Dave that the EPA were not going to act on the complaint - that the call was a courtesy call to make us aware that a complaint had been made.</p> | <p>Dave explained to Stuart that on Wednesday 13<sup>th</sup> there was a fire up near Stanford Merthyr that was blowing smoke our way. We were not processing due to routine maintenance. There was no turning of the mulch stockpile due to wind. 42,500 litres of water was used for dust suppression that day.</p> <p>Dave also pointed out that we were the only business along Racecourse Road that undertakes dust suppression activities and other business also contributed to dust. Dave and Helen had a conversation about different ways that dust could be mitigated including setting up sprays on all stockpiles and watering through the night. Also having sprays set up to wet down material being tipped off trucks.</p> |

He said that "the boys" said they were getting concrete dust and water mixed in their cars. I explained that the EPA was very insistent that we have no dust leave site and we had to do it. He said ok and the call was terminated. |  |
| 21 <sup>st</sup> May 2018 | <p>Anonymous complaint to LMCC</p> <p>Anonymous caller also made a complaint to the EPA</p> | Keith Lainson from LMCC came to site after an anonymous complaint was made about wetting Racecourse Road outside our site.  | <p>Keith inspected the site with Pat (Weighbridge Officer) and was satisfied that what we were doing was satisfactory to mitigate dust. He could see no evidence of water entering Cockle Creek. He told Pat that he would not be contacting the EPA because he felt that what we were doing was not damaging the environment.</p> <p>Melissa Moore from EPA phoned Dave Cross (Yard Manager). Dave told Melissa that the council inspector had been and that he was taking no further action regarding wetting Racecourse Road down. Melissa and Dave discussed the "fine line" between mitigating dust and causing a road hazard. Melissa said she would come to site the next day. We have not seen her as yet.</p> |

Dave explained that we had purchased a new watercart and sweeper (the sweeper was to arrive soon) so the road could be swept daily to try to minimise the amount of water we would need to use. Grace asked Dave to provide photos of Racecourse Road – which he did. He said he drove out here to have a look. He said there was dust coming from the stockpiles. I explained that the watercart ran all day to try to mitigate the dust but it was a particularly windy day.</p> <p>I phoned and spoke to Warren again after I spoke to Mark and Pat and explained what was done on the day to mitigate the dust. He said he understood, he was a concreter, but just wanted to let us know. He said he hadn't phoned the Council.</p> | <p>It was an extremely windy day – 26<sup>th</sup> October 2019. Willy Weather says highest wind gust was 38.7km/hour</p> <p>I spoke to both Mark and Pat regarding this. No processing occurred on Saturday, there were also no excavator movements either. Mark decided that it was pointless to put sprinklers on the stockpiles due to the wind. The water wouldn't have even hit the stockpiles before the wind took it away. There was also work being done on the railway behind us and they had no dust mitigating activities.</p> <p>Pat put 53,000 litres of water that day – using the cannon and around the yard. He said that as he was driving down to fill the watercart he could see dust coming from all businesses along Racecourse Road. In fact he thought Concrush was the only one that wasn't emitting dust!</p> |

We had a significant rain event that day and there was no airborne dust emitting from site. It's possible the complainant was referring to other industrial tenants. Kevin Thompson was on site from 8.30 am – 4.00pm and observed our sweeper on Racecourse Road and road conditions at times during the day. KT did not observe mud on Racecourse Road.</p> <p>As a response to the complaint, KT asked our Operations Manager to take mid-morning and mid-afternoon photos each day and make sure that the sweeper/watercart operates as needed to keep the road clear.</p> |
